Winter Sports and Trail Grooming Equipment

#### Background

The Parks and Recreation Commission currently offers cross-country skiing at two locations. There are three (3) miles of groomed cross-country ski trails, classic and skating styles, at Independence Lake County Park. Another three (3) miles of groomed cross-country ski trails, along with a sledding hill, are located within Rolling Hills County Park. Recent land acquisitions expanded both park units, enabling expansion of the current crosscountry ski trails. However, the existing grooming equipment is old and inefficient.

#### Discussion

The existing snow grooming equipment is a combination of borrowed, "home-made" and manufactured equipment. At both parks, the grooming equipment is towed by old, outdated vehicles which are not owned by the Commission. Rolling Hills uses the Park Superintendent's personal 1995 Polaris (340 cc engine, 15" wide track, and no reverse gear) snowmobile. Independence Lake utilizes a 1970's era Ski-Doo Alpine on Ioan from the A2 Ski Club (36" wide tracks, no electric start, and no reverse gear). The grooming equipment is a similar assemblage of "innovative re-use". Rolling Hills uses a manufactured grader and classic style track setter acquired in the 1980's. Independence Lake's equipment is a "home-made" snow packer made by WCPARC maintenance crew and manufactured grader and classic track setter, age unknown. We have no equipment suitable to address frozen or hard crust trail conditions. Each piece of equipment requires a separate pass, certainly an inefficient us of staff time, inhibiting our ability to maintain quality trails, and limiting our ability to expand the number of miles being groomed.

More efficient snowmobiles suitable of performing grooming tasks under light and heavy snow conditions, coupled with grooming equipment that will perform multiple tasks in one pass, will allow us to more effectively provide a quality recreation experience. Attached for your consideration are bid tabulations, illustrating the cost of two (2) snowmobiles and groomers with the necessary features. The low bid for the snowmobiles is \$21,585 from C and C Sports. The low bid for the groomers is \$11,790 by Yellowstone Track Systems, Inc. The total cost of all necessary equipment is \$33,375.

#### Recommendation

It is my recommendation that the Washtenaw County Parks and Recreation Commission authorize purchase of the following equipment: two (2) Ski-Doo Skandic SWT snowmobiles from C and C Sports and two (2) 84" Model Ginzugroomers from Yellowstone Track System, Inc., at a total cost of \$33,375.
