**RE:** Recommendation for property acquisition from Round 12 Applications

Ordinance No. 128 established the Natural Areas Preservation Program to preserve and protect unique natural areas within Washtenaw County and charged the Parks and Recreation Commission with responsibility for implementing the program. The Ordinance also established the Natural Areas Technical Advisory Committee to serve as an advisory body to assist the Parks and Recreation Commission in consideration of potential property for acquisition.

The 1<sup>st</sup> applications from property owners were received in Spring 2002. Since that time there has been a total of 12 rounds of applications. In rounds 1 through 11, 168 property nominations totaling 9077 acres were received. During the  $12^{th}$  round of nominations, 35 more properties were submitted for consideration, totaling 2192 acres. Each property was reviewed according to the Property Screening System developed by the Committee and adopted by the Commission, just as was done with properties nominated in Rounds 1 – 11. Based upon that review, the following recommendation was developed by the Natural Areas Technical Advisory Committee at their November 5, 2012 meeting:
