# **Candidates for Ann Arbor City Council**

#### WARD I

## Sabra C. Briere (D)

# 1. What is your position on public funding for arts and culture?

I work for a non-profit, The Corner Health Center, that benefits directly from MCACA grants. These grants support our Theatre Troupe, and have provided support for this innovative and successful health education/theatre training program for years. By using a mix of public funds and funding from private foundation and corporate sources, the Theatre Troupe has been able to bring is health education message – teaching about HIV/AIDS, smoking and drug use prevention, domestic abuse, and depression – to middle and high schools in Washtenaw and western Wayne counties. Without public funding, the ability of Troupe staff to teach technique and health education to the troupe members, transport Troupe to the schools, and evaluate the success of the program is placed in jeopardy. Because I have this direct experience, and have been involved in the grant writing process, I really understand the value of public funding for the arts. A small program can fail without a little grant – and a major program, like Wild Swan, can fail utterly if its funding dries up at a critical time.

# 2. If elected, what measurable actions will you take to ensure that arts and cultural offerings survive and thrive in Washtenaw County? Please be specific.

I will continue to work with members of Council and the County Board of Commissioners as well as The University of Michigan to ensure that Ann Arbor and Washtenaw County remain able to provide the highest possible levels of funding for arts venues. I recognize that, in these difficult economic times, the State of Michigan has grossly reduced funding for the arts. However, a vibrant cultural experience provides tourist opportunities, not only here in Ann Arbor but throughout the state. To limit funding for the arts is to limit income-generating activities that reach far beyond the arts themselves. Performance arts and arts events bring dollars to communities through meals eaten, gas purchased, hotel rooms rented, souvenirs and other purchases made . . . indeed, through many channels. I will lobby on behalf of the arts to strengthen our ties to Lansing, and will work to keep arts programs funded. I am aware that there are many different types of public and private funding partnerships needed in Ann Arbor to keep our vibrant cultural life exciting and varied. I expect to continue my support of the arts in many active ways.

# Mitchell Ozog (No Party Affiliation)

1. What is your position on public funding for arts and culture?

# Stephen Rapundalo (D)

## 1. What is your position on public funding for arts and culture?

A strong, vibrant and diverse arts and cultural sector supported through public funding is simply a wise investment in our community. Our arts and cultural assets enrich our lives and enhance the community's appeal to others. The health and quality of an arts and cultural sector should be a distinct competitive advantage for any community, especially one like Ann Arbor. It is a defining element of our regional, national and worldwide image, a key facet of our economy and an important resource for educating our children. In short, it is a non-negotiable, must-have quality that every successful and vibrant community must have.

The current economic conditions have made it clearer than ever that the arts and culture community needs public funding that is stable and dependable. This would allow us to continue offering exceptional experiences for our communities and an ability to compete for knowledge workers and industries. Obviously, identifying a stable funding source is not an easy task given budgetary challenges at all levels of government. However, we must bring together a broadbased coalition of arts organizations, local government units, business leaders, economic development organizations, and others, and lobby strenuously and in a deliberate manner for funding with our elected officials. While some of this is ongoing, it seems that we can and should be doing more. Specifically, a community dialog between stakeholders is needed to help identify possible local approaches for public funding.

# 2. If elected, what measurable actions will you take to ensure that arts and cultural offerings survive and thrive in Washtenaw County? Please be specific.

Several options are worth exploring that might assist the sustainability of the arts and cultural community in small but meaningful ways. For instance, we could consider developing a revolving loan program for artists' materials and transportation on signed contracts for goods and services. This is similar to what is already available to high-tech entrepreneurs in the area. Structured opportunities for networking and partnership between the arts and business communities need to be enhanced - again this has worked well between the entrepreneurial and investment communities. Lastly, there needs to be some tangible movement towards creating low-cost work/live and work space for artists.

# 1. What is your position on public funding for arts and culture?

The Arts Alliance's highly informative and thought-provoking "Top 10 Facts about Arts and Culture in Washtenaw County" deserves to be widely distributed and provides the context for my answer. Public funding for arts and culture, even in today's economic climate, or especially because of today's economic climate, should not be seen as an extravagance or unnecessary "frill." Public funding for the arts and culture is a sound investment in the social and economic life of Ann Arbor and Washtenaw County. Of course, public funding cannot be the sole or main support of arts and culture. Fiscally responsible government that avoids wasteful and unnecessary spending, and that institutes cost-saving efficiencies in the delivery of city services, helps to relieve the tax burden on individuals and organizations, enabling them to earmark funds for the arts and culture.

# 2. If elected, what measurable actions will you take to ensure that arts and cultural offerings survive and thrive in Washtenaw County? Please be specific.

Creative artists are typically low earners, especially at the beginning of their careers. I know many such people in the Fifth Ward. We must keep Ann Arbor and Washtenaw County affordable so that creative artists can continue to live here. We know that affordable studio spaces, for both visual and performance artists, is already very limited, and is shrinking more with each day. I support the Ann Arbor Art Center's exciting proposal for a Cultural Center at 415 Washington and will continue to do so. I believe that a "Percent for Art" law should be passed by the Ann Arbor City Council, as it has been in many cities. This would guarantee that one percent of the budget for eligible City-funded construction projects be spent on artwork, either as part of the design or as purchases. Further, I think that local artists should be given preference when it comes to commissions and acquisitions. Locally-known artists – the nationally-known artists of the future – deserve to have their works displayed and their talents nurtured. Developers seeking approval of construction projects should also be required to

include public art, preferably by local artists. These goals are important to me, and I intend to propose effective measures to the Ann Arbor City Council to achieve them.

### I. What is your position on public funding for arts and culture?
