I request and authorize any person or institution with any records or knowledge of my person and character, including information that might otherwise be considered privileged or confidential, to furnish such information as may be requested by the Office of the Governor or its agents. I understand this authorization will terminate with the rendering of an evaluation to the Governor or upon my written withdrawal of this authorization, which withdrawal shall result in the immediate discontinuance of the processing of this questionnaire.

I release and discharge from all liabilities whatsoever the Governor and his staff, the members of the Standing Committee on Judicial Qualifications, staff members of the State Bar of Michigan and the Attorney Grievance Commission, individually and in their representative capacities, and any person or institution that furnishes information to them for my evaluation as a judicial candidate.
