Re: FY 2012 Federal Program of Projects

In January, the Board adopted a revised 5-year capital and categorical grant program (CCGP). The FY2012 program is unusually large and complex. It includes replacement large and small buses, buses and vans for service expansion, the completion of the bus storage expansion, additional funds for the reconstruction of the BTC, and a number of smaller and standard capital and operating items. It is also complex because funds are coming from 5 different federal programs.

Normally, the current year element from the CCGP is put into the format required by the Federal Transit Administration (FTA) quickly and the AATA conducts the required public hearing before submitting the applications. This year, the process has been delayed as we have been working with the FTA on the specific amounts from each program.

The Program of Projects in the required format is attached. A public hearing will be conducted at the beginning of the June board meeting on this Program of Projects.

It is important to understand that the public hearing is just the final element in public input. The adoption by the Board of the Capital and Categorical grant program in January followed a two-month period beginning in November by the Board's Planning and Development Committee (PDC) at meetings which are open to the public. The information from the PDC meetings is transmitted to the Board at their monthly meetings which are also open to the public. The proceedings of the Board and PDC are published on the AATA's website and are provided directly to interested parties.

A previous opportunity for public input is conducted by the Washtenaw Area Transportation Study (WATS) as part of the overall transportation program for the County. The multi-year CCGP is included with the other transportation projects in the County in the Transportation Improvement Program (TIP), and the WATS public input process provides opportunities for the public to be involved in transportation planning early in the process and for all modes.
