**STIPULATION AND ORDER**  
**DETERMINING ATTORNEY'S FEES AND COSTS**

THE PARTIES HEREBY STIPULATE AS FOLLOWS:

1. In its May 20, 2014 Opinion and Order, the Court ordered that Plaintiff was awarded all reasonable attorney's fees and costs.

2. Pursuant to this Order, Plaintiff filed his Motion for Determination of Attorney's Fees and Costs, pursuant to Local Rule 54.1, on June 6, 2014.

3. In lieu of filing a response to the Motion, Defendants have filed this Stipulation and agreed not to contest the award of fees and expenses recited in Paragraph 4, infra, based upon Plaintiff agreeing to an hourly rate of \$325, rather than the \$400 per hour sought in the Motion.

4. Defendants shall pay to Plaintiff attorney's fees and costs of \$30,731.75, consisting of attorney's fees in the amount of \$30,306.25 (93.25 hours at \$325.00 per hour) and costs in the amount of \$425.50. Payment shall be made on or before July 15, 2014 and shall be made to Plaintiff's attorney at his address shown above.

5. This Stipulation is made for the purpose of resolving any and all claims arising from, or related to, the Court's award of attorney's fees and costs to Plaintiff in the above-entitled case.
