# RECALL PETITION

We, the undersigned, registered and qualified voters of the county of \_\_\_\_\_ of the State of Michigan, residing at the places set opposite our names, petition for the calling of an election to recall **RICHARD D. SNYDER**, from the office of **GOVERNOR OF THE STATE OF MICHIGAN**, for the following reasons:

Richard D. Snyder has requested from the legislature, approved and signed various laws that take authority and funds from local governments and school districts and vest them with the state. He has obtained for himself, through his appointed Emergency Financial Managers, the power to invalidate legal and binding contracts entered into by properly elected local authorities. He has sought tax increases upon retirees and lower income families, but instead of addressing the deficit, he has sought large new tax cuts for corporations and businesses.

The undersigned circulator of the above petition further asserts that to his or her best knowledge, information and belief each signature is the genuine signature of the person purporting to sign the petition, the person signing the petition was at the time of signing a qualified registered elector of the City or Township listed adjacent to each signature, and the elector was qualified to sign the petition.
