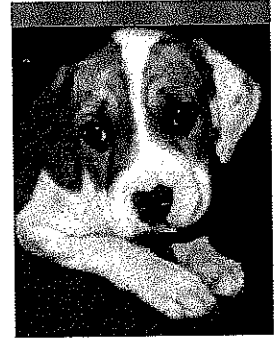

Of the 1,112 dogs and cats that were humanely euthanized, 41 percent had behavior issues, such as aggression or extreme under socialization; 55 percent had serious medical issues, such as FeLV/FIV, parvovirus, or severe injuries. The remaining 4% were animals that we had to put down because we did not have enough resources (e.g., cage space, foster care, adopters, and barn placements) at the time to help them. We strive for an "Adoption Guarantee" for all healthy and treatable animals and have several new exciting initiatives in place for 2011 to help us meet this goal.

\*This is the percentage of all cats and dogs leaving our shelter that were adopted, returned to owners or transferred for alternative placement.
