ANN ARBOR CITY COUNCIL MINUTES WORKING SESSION - JULY 9, 2001

The working session of the Ann Arbor City Council was called to order at 7:03 p.m. in the City Hall Council Chamber by Mayor John Hieftje.

FOOTING DRAIN DISCONNECTION PROGRAM

Water Utilities Director Sue McCormick presented the final report and recommendation of the Sanitary Sewer Overflow Prevention Advisory Task Force. The report recommends proceeding with a city-wide comprehensive footing drain disconnection program to remove rain and ground water inflow sources into the sanitary sewer system. (Report on file in the City Clerk's Office). Ms. McCormick asked for Council's direction to finalize proposed ordinances and program provisions.

Also available to answer questions from Council were project consultant Mark TenBroek, of Camp, Dresser and McKee; Utilities Field Services Senior Engineer Peter Perala; and Public Services Director William Wheeler.

The Mayor declared a recess at 9:55 p.m.

The Mayor again called the meeting to order at 10:04 p.m.

Mayor Hieftje announced that a committee consisting of Councilmembers from the second, fourth and fifth wards will be established to present Council with recommendations on finalizing the footing drain disconnection program.
