# **BOARD ACTION REQUESTED:**

It is requested that the Washtenaw County Board of Commissioners consider approval of the attached Resolution, calling for a Public Hearing to be held before the Washtenaw County Board of Commissioners on April 2, 2014. The Public Hearing will serve as the mechanism for citizens and taxing jurisdictions to provide comment on the proposed Brownfield Redevelopment Plan for The Historic Thompson Block, 400-408 North River Street and 107 East Cross Street, Ypsilanti, MI 48197, prior to the Board of Commissioners consideration of its approval.

#### **BACKGROUND:**

In May of 1999, the Washtenaw County Board of Commissioners established the Washtenaw County Brownfield Redevelopment Authority (WCBRA) through Resolution 99-0110. On May 4, 1999, the City of Ypsilanti joined the WCBRA as a municipal member, by adoption of a resolution.

Pursuant to the Brownfield Redevelopment Financing Act (PA 381 of 1996, as amended), the WCBRA is preparing a Brownfield Redevelopment Plan for the Thompson Block Redevelopment Project, to be eligible for capture of Tax Increment Financing using State of Michigan School Taxes. No local tax millages are proposed for capture utilizing TIF in the Brownfield Plan, based on the projected Taxable Value of the project after completion, and provided the City of Ypsilanti approves an Obsolete Properties Rehabilitation Certificate on the property, freezing local taxes at predevelopment levels at their March 4, 2014 City Council meeting. The Brownfield Plan must be submitted to the Washtenaw County Board of Commissioners for adoption. Prior to that adoption, the law stipulates that a Public Hearing be held.

### **DISCUSSION:**

The Washtenaw County Board of Commissioners has demonstrated its support for the sustainable redevelopment of historic and brownfield sites in Washtenaw County. By establishing and supporting the Brownfield Redevelopment Authority and its Board, the Commissioners have supported and partnered with local units of government to transform underutilized, urban brownfield sites into productive, tax-generating properties. Calling for a Public Hearing on the proposed Brownfield Plan will assist in moving the Authority towards fulfilling its purpose as required by Public Act 381. Further, the Board of Commissioners previously approved a Brownfield Plan for this project in 2008, which is now expired due to project delays.

The Thompson Block Brownfield Redevelopment Plan will support the mixed-use redevelopment of a 150 year-old three-story historic building in Depot Town, consisting of ground floor retail, second floor office and third floor loft apartments. Total project investment is approximately \$7 million. This updated Brownfield Plan incorporates an adjacent eligible property to the east, and with the vacation of a bisecting alley, the larger site provides for innovative stormwater management techniques and off-street parking. In addition, public infrastructure improvements, such as streetscape enhancements along North River Street, are now included in the proposed Plan.

WHEREAS, the Washtenaw County Board of Commissioners supports the sustainable redevelopment of historic and distressed urban sites designated as brownfields;

WHEREAS, the Washtenaw County Board of Commissioners established the Washtenaw County Brownfield Redevelopment Authority to facilitate the implementation of plans relating to the identification and treatment of brownfields in Washtenaw County (Res. 99-0100);

WHEREAS, the Washtenaw County Brownfield Redevelopment Authority (WCBRA) is preparing a Brownfield Redevelopment Plan for the Historic Thompson Block, 400-408 North River Street and 107 E. Cross Street, Ypsilanti, MI, 48197, for tax increment financing, pursuant to and in accordance with the provisions of the Brownfield Redevelopment Financing Act, P.A. 381 of the State of Michigan of 1996, as amended (Act);

WHEREAS, the Brownfield Redevelopment Financing Act calls for the Washtenaw County Board of Commissioners to hold a Public Hearing to receive comment on the proposed Brownfield Redevelopment Plan, following customary County notification requirements before the Public Hearing;

WHEREAS this matter has been reviewed by the County Administrator's Office and the Corporation Counsel;

NOW THEREFORE BE IT RESOLVED, that a Public Hearing shall be held before the Washtenaw County Board of Commissioners on April 2, 2014, at 6:45 p.m., in the Board Room at 220 N. Main St., Ann Arbor, Michigan, to receive comment on the adoption of the Brownfield Redevelopment Plan for the proposed Historic Thompson Block, 400-408 North River Street and 107 E. Cross Street, Ypsilanti, MI 48197.
