WHEREAS, Ms. Kelly has served on the Washtenaw County Police Services Steering Committee since its inception in 2006 and worked diligently to bridge the divide between contracting and non-contracting municipalities, to promote transparency and accountability in contract pricing for police services and to foster a positive relationship between contracting units and the Sheriff's Office; and

WHEREAS, Ms. Kelly has been a leader on many issues of countywide significance and organized bringing together her peers and colleagues by convening and moderating monthly Chief Elected Official meetings; and

WHEREAS, Ms. Kelly led Dexter Township's response to a devastating tornado in 2012 and worked tirelessly and diligently to establish communication channels with affected residents, safely coordinate volunteer efforts to aid in the massive clean-up, and, with significant and important assistance from the County and Road Commission, supported and led township efforts to remove debris and fallen trees from private property at little or no cost to residents; and
