SUBJECT: 2014 County Operating Millage Rate

BOARD ACTION REQUESTED:

It is requested that the Board of Commissioners set the 2014 Washtenaw County Operating Millage Rate.

BACKGROUND:

Each year, the Board of Commissioners adopts a resolution setting the county's millage rate. In the past, this rate was set in the fall for use in the December tax levy and included all county related millages: General Operating, Drain Assessment, Parks, Natural Areas, Huron-Clinton Metropolitan Authority taxes, and the Enhanced Emergency Communications System (EECS) 800 MHZ initiative. Due to the State of Michigan legislation shifting the County's general operating millage levy from December 1st to July 1st, it is now necessary for the Board of Commissioners to adopt the general operating millage earlier in the year for the local units of government to have the appropriate millage rate to include on the July 1st tax bills. In addition, the Board of Commissioners authorized two millages beginning in 2009 to provide revenue for the following years: Veteran's Relief and Public Act 88. These millages will be brought to the Board for consideration for the December 1, 2014 tax levy at a later date.

DISCUSSION:

The resolution establishes the 2014 Washtenaw County General Operating Millage Rate at 4.5493. This figure is based on the 2014 Taxable Value and will be used to levy property taxes for the County's 2014 General Fund fiscal year. The 2014 Millage Rate of 4.5493 is the same amount as applied in 2013. This is due to the County realizing a Headlee factor of 1.0 thereby retaining the same millage rate as in the prior year.
