I was astounded to read this morning in annarbor.com that my new neighbor at is going to be a medical marijuana dispensary. (This would explain why the workers have refused to tell me what type of business is moving in.)
Unlike the other businesses in the neighborhood, that little plot of land is zoned C1. According to the city's planning code:
5:10.15. C-1 Local Business District. (1) Intent. A business district designed solely to serve the needs of the surrounding residential neighborhood, providing goods that are day-to-day needs and are classed by merchants as "convenience goods and services." The normal spacing between these shopping districts is approximately 1 mile, and the total land area averages 2 acres. Businesses which might tend to be a nuisance to the immediately surrounding residential development are excluded, even though the goods or services offered might be in the convenience category or classification. The regulations are designed to permit development of the enumerated functions as limited by the standards designed to protect the abutting or surrounding residential land. To these ends, the regulations establish standards comparable to the standards for residential districts resulting in similar area, height and placement regulations.
There is a four-foot-high chain link fence separating us. One of the people working on the property asked me a couple of weeks ago if he could put up a very high wooden fence from the sidewalk about 10 feet back into the property (along the parking lot), but leave up the chain link fence that separates the side of the building from my backyard, 'so no one goes back there and can't be seen.' (The only person that could see them is me, so I guess I'm supposed to be their security system?) The entire length of the building is literally 24 inches from the fence, and all of the windows have been covered up. I am not the owner of the property; I am a renter. My landlord has been seriously ill, and he may not be able to lodge a

I do not feel that the proprietors of that business can provide the proper security in a residential neighborhood,
especially with the comment they made to me about the chain link fence. I have e-mailed two people in the planning
office, and have not gotten a response. That has, for the most part, been a nice, safe place to live. I no longer
feel safe there. If there is a break-in in that business, the only escape route for the perpetrators will be my yard. Please
enforce the zoning for this lot.
